Dear Parent/Carer,

We would like to invite your child to participate in our research project, which is led by Dr Susanne Schweizer at the University of New South Wales (UNSW) School of Psychology and has been approved by UNSW Human Research Ethics Committee [Project ID Number: HC230164]

Before you decide whether your child may take part, we would like to tell you why the research is being done and what it will involve.

Please take time to read the following information carefully and discuss it with your child. A member of the team can be contacted if you have any questions about any aspect of the study.

1. What is the research study about?

Good emotion regulation in teenagers is associated with better wellbeing and academic outcomes. Neuroscientists have shown that emotion regulation can be improved by training the core cognitive processes it relies on.

This study is investigating whether we can enhance two different types of emotion regulation training to find out whether one is more successful than the other at improving emotion regulation, especially in social situations.

3. Inclusion/Exclusion Criteria

Before you decide to allow your child to participate in this research study, we need to ensure that it is ok for your child to take part. The research study is looking to recruit people who:

- Are aged 13 16 years.
- Speak English with native fluency
- Have daily access over the course of the training period to a smartphone or tablet with internet connection and access to the Apple or Google Play app store

No history of traumatic brain injury

4. Does my child have to take part in this research study?

No, participation in this research study is voluntary. Additionally, if you agree for your child to take part in the study and later change your mind, you are free to withdraw your child from the study at any stage.

If you decide you want your child to take part in the research study, you will be asked to:

- Please go to read this information (ask questions you may have) and indicate your consent below.
- Keep a copy of the consent form for your records.

If you consent to your child's participation, we will also ask your child if they agree to take part. We will do this by sending them a link to an online information sheet and consent form.

5. What does participation in this research require, and are there any risks involved?

There are 4 phases to this research study, all of which are completed online.

Phase 1: Questionnaires & tasks before training

In the first stage of the study, your child will be asked to complete a series of questionnaires relating to demographic characteristics (incl. age, gender, ethnicity), mental and emotional wellbeing (incl., emotion regulation, symptoms of mental health) and social functioning. Additionally, your child will also complete two computerised tasks that measure memory and social thinking.

These questionnaires and tasks should be completed in a quiet location. This phase will take approximately 60 minutes to complete.

Phase 2: Cognitive training

In Phase 2 your child will receive one of two training programs that are designed to improve emotion regulation. In both programs, your child will be asked to complete a minimum of 10 minutes of training/day for 12 days.

If your child is allocated to training A, they will complete a social memory task which involves tracking the location of emotional faces and remembering emotional words.

If your child is allocated to training B, they will complete the same memory activity as training A and additionally resolve social puzzles.

Phase 3: Questionnaires & tasks after training

In Phase 3, the measures (with the exception of demographics) from Phase 1 are completed again.

Phase 4: 1- month follow up questionnaires

In Phase 4 the questionnaires from Phase 3 will be completed again. This will take **approximately 20 minutes to complete**.

Additional Costs and Reimbursement: There are no costs associated with participating in this research project. Your child will receive an AU\$50 (25GBP) Prezee voucher (valid at multiple retailers including Woolworths, Uber Eats, Amazon, David Jones, Rebel, JB Hi-Fi) via email after completing Phase 3. Your child will receive an additional AU\$10 (5GBP) Prezee gift voucher for completing the one-month follow up (Phase 4).

Please note, your child will only receive compensation if they complete the study faithfully. We test this in two ways: (1) by including items that check they are reading and paying attention to the questions at each assessment point (phase 1, phase 3 and phase 4) and (2) by checking that their performance on the cognitive tasks are within the range of human responses. At each assessment point, they must complete at least 3 of the 5 attention items correctly to receive compensation.

Psychological Distress: Your child may find some of the questions upsetting. If your child does not wish to answer a question or complete a task, they may skip it and go to the next question or task, or they may stop immediately. Although some questions included in the study assess mental health, these questions are not a diagnostic measure. As such, there will be no reporting of or follow-up procedures for these questions and you and your child will not be able to access individual data.

If your child becomes upset or distressed as a result of participation in the research project, they can contact the research team at any time. Alternatively, a number of free contactable support services are included in section 10.

6. What will happen to information about my child?

Personally identifiable data will be stored for 7 years. After that period, all personally identifiable data will be deleted.

Completely anonymised (that means you and your child cannot be identified by any means) data will be made available to other researchers on an open access data repository. Researchers who would like to use this data can request it from the research team.

The information you or your child provides is personal information for the purposes of the Privacy and Personal Information Protection Act 1998 (NSW). You have the right of access to personal information held about you by the University, the right to request correction and amendment of it, and the right to make a complaint about a breach of the Information Protection Principles as contained in the PPIP Act. Further information on how the University protects personal information is available in the UNSW Privacy Management Plan.

7. How and when will I find out what the results of the research study are?

The research team intend to publish and report the findings of this research in scientific journals and at scientific conferences. All Information will be published in a way that will not identify you or your child.

Your decision not to participate or to withdraw from the project will not affect your relationship with UNSW Sydney. If you decide to withdraw from the project, the researchers will not collect additional information from you or your child. You can request that any identifiable information about you or your child be withdrawn from the research project.
